I, the above named participant being 18 years or older in age, or the legal guardian of the above named participant who is under 18, in consideration of the services CISCO Soccer Club, its officers, directors, members, managers, employees, coaches, officials, agents & representatives, herein collectively referred to "Releases" hereby acknowledge, agree, promise & covenant with Releases on behalf of myself, my personal representatives, my heirs as follows: **1) I understand & acknowledge that all fees which include registration, uniforms, Club/training fees & any applicable team fees are accrued at the beginning of the season & are non-refundable.** I also understand that Club/training fees are assessed on a yearly basis & are due & payable in full upon registration. Player's parents or guardians may enter into an agreement to pay the fees in installments. All costs are payable in full regardless of player's ability or willingness to compete. Club fees are non-refundable & are due & owing for the year, even if the player leaves CISCO Soccer Club. If the above mentioned fees are not paid in full, I understand that the player owing will be placed in Bad Standing & CISCO will take all appropriate actions until the debt is paid in full up to & including possible legal action. Players receiving discounted fees/scholarships may be required to perform volunteer services or assist in fundraising at the discretion of the Club. **2) I understand & acknowledge that the activity that I am about to voluntarily engage in as a participant and/or volunteer bears certain known & anticipated risks which could result in INJURY, DEATH, PHYSICAL OR MENTAL ILLNESS OR DISEASE, THEFT OR DAMAGE to myself or property.** This risks include, but are not limited to the following: (1) the risks which are inherent in the activities of which I am registered, tournaments, events & competitions; (2) the acts, omissions or negligence in any degree of Releases; (3) latent or apparent defects or conditions in equipment, property or facilities provided by Releases; (4) physical contact with other participants, whether or not contact is intentional; (5) my own physical condition or lack of thereof; (6) first aid, emergency treatment, or other services rendered or failed to be rendered by Releases; (7) risks of contact by equipment, balls, or other components utilized by other participants, players or competitors. **3) Hereby Releases, waives, discharges, & covenants not to sue CISCO Soccer Club & all Releases from any and all liability in any way connected with my participation in this activity.** I further agree to indemnify & save & hold harmless the CISCO Soccer Club & the Releases from any loss, liability, damage or cost they incur due to the presence of the undersigned in any way participating in a CISCO Soccer Club event whether caused by negligence of the Releases or otherwise.
